2 AMENDING PART II, CHAPTER 1 OF THE SAN FRANCISCO MUNICIPAL CODE  
3 (BUILDING CODE) SECTION 106.3.2.3.2 TO PROVIDE NOTICE OF APPLICATIONS FOR  
4 AND ISSUANCE OF DEMOLITION PERMITS TO RECYCLING COMPANIES UPON THEIR  
5 PAYMENT OF A SPECIFIED FEE.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The San Francisco Building Code is hereby amended by amending  
9 Section 106.3.2.3.2. to read as follows:

10 **SEC. 106.3.2.3.2 Notice to interested parties.** Any of the following organizations or  
11 groups ((with an interest in architectural or historical preservation or housing conservation))  
12 may request notification of the receipt by the Department of an application for a demolition  
13 permit and of the issuance thereof:

- 14 1. architectural or historic preservation or housing conservation groups
- 15 2. recycling companies.

16 Such request shall be in writing to the Department, on forms furnished by the  
17 Department. The organization or group shall specify the area(s) of the City and County of  
18 San Francisco for which notification is requested and the Director shall establish the  
19 boundaries of such areas for purposes of such notification. Requests shall be made  
20 annually, within 30 days after July 1 of each year. See Section 110, Table 1-L – Public




