4th Amendment to Aramark Contract

Overview

- The Sheriff's Department requests approval to extend the current contract with Aramark, to provide jail food services, from June 30, 2018 to October 31, 2018
- Current Aramark Contract: Term July 1, 2012 to June 30, 2018
 - Original Contract: Term July 1, 2012 to June 30, 2017; with two one-year options
 - 1st Amendment: Term revised to July 1, 2012 to June 30, 2016 with two one-year options
 - 2nd Amendment: Exercised 1st one-year extension; Term June 2012 to June 2017
 - 3rd Amendment: Exercised 2nd one-year extension; Term June 2012 to June 2018
- Proposed 4th Amendment
 - Extends current contract terms four months from Jul 1, 2018 to Oct 31, 2018

4th Amendment to Aramark Contract

Reasons for Proposed 4th Amendment

- New food service contract awarded to Aramark in March 2018 following a competitive bid process (RFP #SHF2018-01)
- Term extension of current contract allows time to finalize scope-of-service details on new jail food service contract:
 - Good Food Purchasing Program requirements
 - Enhanced hot dinner meals for inmates
 - Coffee service to inmates
 - Compliance with San Francisco Environment Code Chapter 27: Antibiotic Use in Food Animals
 - Compliance with the proposed amendment to Chapter 16 of the San Francisco Environment Code: Waste Reduction Ordinance to prohibit the use or distribution of food service ware made with plastic and with fluorinated chemicals
- Budget & Legislative Analyst determined contract-term-extension legislation will have no fiscal impact

July 2017

- ✓ Executed contract with Center to conduct baseline assessments for Zuckerberg General Hospital & Laguna Honda Hospital

Summer 2017

- ✓ Initiated data collection for baseline assessments. Received purchasing records from US Foods.
