6 WHEREAS, The Board of Supervisors approved the Agreement with PRWT Services,
7 Inc. with Resolution No. 593-98 on July 31, 1998; and,

8 WHEREAS, The Board of Supervisors approved two 2-year extensions to the
9 Agreement with PRWT Services, Inc. with Resolution No. 677-02 on September 30, 2002 and
10 Resolution No. 515-04 on August 17, 2004; and,

11 WHEREAS, The Municipal Transportation Agency has improved the quality of service
12 provided to the public, become more efficient and has upgraded its information systems used
13 for processing parking citations through its Agreement with PRWT, Services, Inc.; and,

14 WHEREAS, The Municipal Transportation Agency Board of Directors adopted
15 Resolution 06-107 on ~~August 1, 2006~~ ^{August 15, 2006} approving a two-year extension to the
16 Agreement with PRWT Services, Inc. and is on file with the Clerk of the Board of Supervisors
17 in File No. 061067; and,

18 WHEREAS, The Municipal Transportation Agency has requested the Board of
19 Supervisors approve a Sixth Amendment to the Agreement with PRWT Services, Inc. which
20 includes a two-year extension because the contract benefits have exceeded the costs; now,
21 therefore, be it

22 RESOLVED, That Board of Supervisors of the City and County of San Francisco
23 hereby approves the proposed Sixth Amendment to the Agreement with PRWT Services, Inc.
24 for a period of up to two years, from September 24, 2006 through September 23, 2008, and
25 increases the "not to exceed" amount from \$63,125,780 to \$78,983,280; and, be it


