3 **Ordinance authorizing settlement of the lawsuit filed by Rudy Perez Mejia against the**
4 **City and County of San Francisco for \$150,000; the lawsuit was filed on April 17, 2017,**
5 **in San Francisco Superior Court, Case No. CGC-17-558193; entitled Rudy Perez Mejia v.**
6 **City and County of San Francisco, et al.; the lawsuit involves alleged personal injury**
7 **from a vehicle accident.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Rudy Perez Mejia v. City and County
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-17-558193 by the
13 payment of \$150,000. The lawsuit involves alleged personal injury from a vehicle accident.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 April 17, 2017, and the following parties were named in the lawsuit: Plaintiff: Rudy Perez
16 Mejia; and Defendants: City and County of San Francisco and Gilbert Mercadel.
