3 **Resolution determining that the transfer of a Type-21 off-sale general beer, wine,**
4 **and distilled spirits liquor license to Grocery Outlet Inc, doing business as**
5 **Grocery Outlet, located at 355 Bayshore Boulevard (District 10), will serve the**
6 **public convenience or necessity of the City and County of San Francisco, in**
7 **accordance with California Business and Professions Code, Section 23958.4; and**
8 **requesting that the California Department of Alcoholic Beverage Control impose**
9 **conditions on the issuance of the license.**

11 WHEREAS, Grocery Outlet Inc, is seeking the transfer of a Type-21 off-sale
12 general beer, wine, and distilled spirits liquor license to do business as Grocery Outlet,
13 located at 355 Bayshore Boulevard (District 10); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) Sales, service and consumption of alcoholic beverages shall be permitted
22 only between the hours of 7:00 a.m. and 11:00 p.m. each day of the week; 2) The sale
23 of distilled spirits in sizes smaller than 200 milliliters is strictly prohibited; 3) Beer, malt
24 beverages, and wine coolers in containers of 16 ounces or less cannot be sold by single
25 containers from a refrigerator or cooler but must be sold in manufacturer pre-packaged

1 multi-unit quantities; this restriction applies to any beer that is not sold or marketed by
2 the manufacturer in a multi-unit package quantity; and 4) Petitioner(s) shall actively
3 monitor the area under their control in an effort to prevent the loitering of persons on
4 any property adjacent to the licensed premises as depicted on ABC-253; now,
5 therefore, be it

6 RESOLVED, That in accordance with California Business and Professions Code,
7 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
8 hereby determines that the transfer of a Type-21 off-sale general beer, wine, and
9 distilled spirits liquor license to Grocery Outlet Inc, doing business as Grocery Outlet,
10 located at 355 Bayshore Boulevard, will serve the public convenience or necessity of
11 the City and County of San Francisco; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
13 San Francisco hereby endorses and adopts the recommendations of the Police
14 Department listed above and recommends that the Department of Alcoholic Beverage
15 Control issue the license with those conditions.
