WHEREAS, On October 30, 1998, PUC Sewer Operations identified an emergency condition on Polk Street from Grove Street to McAllister Street; and

WHEREAS, The existing brick sewer had a large crack in the crown and missing bricks, and immediate replacement were required in order to protect the health, welfare, and property of the Citizens of San Francisco; and

WHEREAS, DPW's Bureau of Engineering prepared the Plans and Specifications for Contract No. CW-221E, "Polk Street Emergency Sewer Replacement" to replace the existing 3'x5' brick main sewer on Polk Street from Grove Street to McAllister Street with approximately 560 linear feet of 16-inch diameter PEP sewer; and

WHEREAS, The Contractor, Uniacke Construction, Inc., began the emergency work on November 9, 1998 and completed it on November 20, 1998; and

WHEREAS, Because this was an emergency contract, HRC subcontracting goals were not established by the HRC Contract Compliance Officer assigned to monitor the Clean Water sewer replacement program; and

WHEREAS, The cost of the project is estimated to be \$98,330.00, of which \$77,380.00 is for the construction contract. Funds are available from the Repair and Replacement Fund (Fund 5C/CPF/R&R, FAMIS Project No. CENRNRR997, Job Order No. 1771N); and

WHEREAS, The Public Utilities Commission, in accordance with the provisions of Section 6.30 of the Administrative Code of the City and County of San Francisco, declared the existence of an emergency; now, therefore, be it

RESOLVED, That this Board of Supervisors hereby approves the expenditure of funds for the
