9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Traffic Code is hereby amended by amending Section
11 68, to read as follows:

12 **SEC. 68. SELLING FROM A VEHICLE RESTRICTED.**

13 (a) It shall be unlawful for any person to park any vehicle upon any street in *Traffic*
14 *Zone No. 1, or* any business district, from which said vehicle merchandise is being sold or
15 offered for sale.

16 (b) ~~Notwithstanding the provisions of Paragraph (a), persons holding peddler's licenses on~~
17 ~~January 1, 1987, to peddle from a vehicle in the area bounded by Hyde Street on the west, Bush Street~~
18 ~~on the south, Montgomery Street on the east and Jefferson Street on the north shall, so long as they~~
19 ~~remain licensed and continue to personally operate their own businesses, be permitted to continue sales~~
20 ~~activity from a parked vehicle except that these peddlers shall be relocated to the south side of the~~
21 ~~blocks of Pacific Street between Stockton and Powell and Powell Street between Pacific and Jackson~~
22 ~~until December 31, 1989, at which time all such permits will expire.~~

23 ~~Each person holding a peddler's permit within the area specified in this Paragraph shall, no~~
24 ~~later than October 1, 1987, surrender that permit to the Chief of Police who shall issue another permit~~

2 ~~permit by October 1, 1987, shall be cause for revocation of said permit.~~

3 ~~(c) A person holding a peddler's license to peddle from a vehicle at the locations specified in~~
4 ~~Paragraph (b) of this Section shall be permitted to peddle between the hours of 8:00 a.m. and 6:00 p.m.~~
5 ~~on Saturday, Sunday, and legal holidays.~~

6 ~~(d) The Chief of Police, or his or her designee, shall be authorized to conduct a lottery on a~~
7 ~~quarterly basis in order to assign each person holding a peddler's license a parking space at the~~
8 ~~locations specified in Paragraph (b) of this Section.~~

9 ~~(e) At the time of the lottery provided for in Paragraph (d) of this Section, a fee shall be~~
10 ~~assessed to each person holding a peddler's license to peddle from a vehicle at the locations specified~~
11 ~~in Paragraph (b) of this Section. Such fee shall include any loss of parking meter revenue as a result of~~
12 ~~the activities of the permittee, at an amount not to exceed \$2.50 per day for those days meters are~~
13 ~~enforced, and any costs to the City for cleaning and maintaining each designated parking space as a~~
14 ~~result of the activities of the permittee, at an amount not to exceed \$12.50 per day.~~


15 ~~(f) The Director of the Department of Parking and Traffic shall post fixed and permanent signs~~
16 ~~designating the parking spaces specified in Paragraph (b) of this Section to be reserved on Saturday,~~
17 ~~Sunday and legal holidays between 8:00 a.m. and 6:00 p.m. for holders of valid peddler permits.~~
18 ~~Vehicles illegally parked will be cited with a fine of \$10, pursuant to the Traffic Fine Schedule of the~~
19 ~~Municipal Traffic Court and towed.~~

20 ~~(g) (b)~~ Any person violating the provisions of Subsections (a) through (e), inclusive, shall
21 be guilty of an infraction. Every violation determined to be an infraction is punishable by (1) a
22 fine not exceeding \$100 for a first violation; (2) a fine not exceeding \$200 for a second
23 violation within one year; (3) a fine not exceeding \$500 for a third violation within one year.


