

1 [Airport Professional Services Agreement Amendment - Curbside Management Program - Not  
2 to Exceed \$15,067,000]

3 **Resolution approving Amendment No. 1 to Professional Services Agreement, Airport**  
4 **Contract No. 8994, to Manage and Staff the Curbside Management Program, between**  
5 **FSP PPM Management, LLC, and the City and County of San Francisco, acting by and**  
6 **through its Airport Commission, in an amount not to exceed \$15,067,000, pursuant to**  
7 **Charter, Section 9.118(b), for the period of July 1, 2013, through June 30, 2014.**

9 WHEREAS, On July 6, 2010, pursuant to Resolution 10-0228, the Airport Commission  
10 awarded the PSA to FSP PPM Management, LLC for a 30-month initial term with three (3)  
11 additional one-year renewal options to be exercised at the discretion of the Airport  
12 Commission, at an initial not-to-exceed amount of \$10,450,000; and

13 WHEREAS, On January 15, 2013, pursuant to Resolution 13-0005, the Airport  
14 Commission approved Amendment No. 1 to the Curbside Management Program Contract  
15 with FSP PPM Management, LLC to exercise the first of three (3) one-year options to renew  
16 the PSA through June 30, 2014 for the amount of \$4,617,000, for a new not to exceed  
17 contract total of \$15,067,000; and

18 WHEREAS, The Airport anticipates the contract duration to be up to five and one-half  
19 (5 ½) years, in an amount not-to-exceed \$26,000,000; and

20 WHEREAS, San Francisco Charter Section 9.118(b) provides that the agreements  
21 entered into by a department, board or commission requiring anticipated expenditures by the  
22 City and County of ten million dollars, shall be subject to approval by the Board of Supervisors  
23 by resolution; and

1           WHEREAS, The Agreement is on file with the Clerk of the Board of Supervisors in File  
2 No. 130391, which is hereby declared to be a part of this resolution as if set forth fully herein,  
3 therefore, be it

4           RESOLVED, That the Board of Supervisors hereby approves Amendment No. 1 to the  
5 Professional Services Agreement for Airport Contract 8994 – to Manage and Staff the  
6 Curbside Management Program between FSP PPM Management, LLC and the City and  
7 County of San Francisco, acting by and through its Airport Commission, to exercise the first of  
8 three (3) additional one-year options for the amount of \$4,617,000, for a new not-to-exceed  
9 total contract amount of \$15,067,000, with an anticipated final contract value not-to-exceed  
10 \$26,000,000, copies of which are contained in Board of Supervisors' File Number 130391.
