

1 [Bulletproof Vest Partnership Grant Act]

2 AUTHORIZING THE MAYOR'S CRIMINAL JUSTICE COUNCIL TO ACCEPT
3 AND EXPEND \$21,000 FROM THE U.S. DEPARTMENT OF JUSTICE UNDER THE
4 BULLETPROOF VEST PARTNERSHIP ACT TO EQUIP LAW ENFORCEMENT
5 OFFICERS WITH ARMOR VESTS,

8 WHEREAS, Public Law 105-181 provides \$25 million dollars for the Bulletproof
9 Vest Partnership Grant Act of 1998 to be administered by the Department of Justice to
10 protect the lives of law enforcement officers by helping units of local government equip
11 their law enforcement officers with armor vests; and,

12 WHEREAS, the Bulletproof Vest Partnership Grant Act directs the Bureau of
13 Justice Administration, Department of Justice, to award \$25 million for bulletproof vest
14 purchases on a competitive basis; and,

15 WHEREAS, the City and County of San Francisco has authorized the Mayor's
16 Criminal Justice Council, in adherence to Department of Justice requirements that the
17 chief executive office of each eligible jurisdiction coordinate vests needs among all law
18 enforcement agencies in their jurisdiction and apply; and,

19 WHEREAS, the Federal grant requires a fifty percent match of each jurisdiction's
20 total award for the purchase of bulletproof vests; and,


21 WHEREAS, the entire award by the Department of Justice's Bulletproof Vest
22 Partnership Grant Act funds direct purchases of vests, it is requested that indirect costs be
23 waived; and,

24 WHEREAS, the City and County of San Francisco has already appropriated over
25 \$21,000 for the purchase of Bulletproof Vests as matching funds; and,

WHEREAS, under the Bulletproof Vest Partnership Grant Act, the City and
County of San Francisco was awarded \$21,000 to purchase 118 bulletproof vests; now,
therefore, be it

RESOLVED, that the City and County of San Francisco hereby authorizes the
1 Mayor's Criminal Justice Council accept and expend \$21,000 in grant funds from the
2 Federal Department of Justice under the Bulletproof Vest Partnership Grant Act.
