Dear Ms. Calvillo,

This letter is to request a determination of public convenience or necessity from the Board of Supervisors for the currently existing 7-Eleven market located at 221 Sansome Street. This request is made by both the franchisee for this 7-Eleven market, which is Mal & S Corporation and is owned by Sarjeet & Malkit Singh, and also by 7-Eleven Inc.

In February 2022, Mr. and Mrs. Singh and 7-Eleven, Inc. applied to the Department of Alcoholic Beverage Control to transfer a Type-20 license from Mainland Market & Produce located at 5601 Geary Blvd. to this 7-Eleven market. This application was made after hearing numerous requests from customers asking why they could not purchase beer and wine at the location and complaining about the inconvenience of not being able to do so. The market completed the 30-day posting requirement for its ABC License on or about March 19th after posting the ABC Notice in a clearly visible location at the front of the store.

As our business is to serve the convenience of our customers, 7-Eleven seeks to now sell a small amount of beer and wine daily between the hours of 6:00 a.m. and 2:00 a.m., as permitted by State law. In order to address any concerns of the neighborhood, this market has agreed to conditions in its ABC License, which are attached as Exhibit 1 and include limitations on the size of beer, malt beverages, and wine that may be sold and also prevents wine from being sold that has an alcohol content greater than 15% by volume. While the sale of alcoholic beverage will be limited as discussed above, the location itself will remain open 24 hours a day, seven days a week.

The issuance of an ABC license to this store will serve the public convenience or necessity of the immediate neighborhood and citywide because it will allow the community to have one-stop shopping for all of their grocery needs. Currently, we sell a full array of grocery products including, but not limited to, milk, cheese, toilet paper, toothpaste, diapers, chips, bread, feminine hygiene products, newspapers, household cleaning products, baked goods, and many other sundries. We receive fresh food deliveries daily and are able to offer our customers prepared foods, fresh fruit, and a coffee bar. With the ability to sell a small amount of beer and wine to complement these grocery items, we can then allow customers to purchase all of their grocery needs at one location, which will serve the public convenience.

Over the years, we have received countless requests from our neighbors and guests at the Four Seasons Hotel across the street from our market to sell beer and wine so that they could purchase all of their grocery needs at one location. Ensuring that the convenience needs of the visitors staying in hotels are met is a benefit to San Francisco as a whole. Additionally, such one-stop shopping will be vital to help sustain the rapid return of people into our local community now that people are returning to their workplaces and seeking quick, convenient methods for in-person shopping. Also, we will provide an alternative to those in the community that do not wish to buy a bottle of wine at a liquor store.





WHEREAS, the proposed premises are located in Census Tract #011.00 where there presently exists an undue concentration of licenses as defined by Section 23958.4 of the Business and Professions Code; and

WHEREAS, pursuant to Section 23958 of the Business and Professions Code, the Department may deny an application for a license where issuance would tend to create or aggravate a law enforcement problem; and,

WHEREAS, the proposed premises and/or parking lot, operated in conjunction therewith, are located within 100 feet of residences(s), and issuance of the applied-for license without the below-described conditions would interfere with the quiet enjoyment of the property by nearby residents and constitute grounds for the denial of the application under the provisions of Rule 61.4, of Chapter 1, Title 4, of the California Code of Regulations; and,







This letter is to request a determination of public convenience or necessity from the Board of Supervisors for the currently existing 7-Eleven market located at 221 Sansome Street. This request is made by both the franchisee for this 7-Eleven market, which is Mal & S Corporation and is owned by Sarjeet & Malkit Singh, and also by 7-Eleven Inc.

In February 2022, Mr. and Mrs. Singh and 7-Eleven, Inc. applied to the Department of Alcoholic Beverage Control to transfer a Type-20 license from Mainland Market & Produce located at 5601 Geary Blvd. to this 7-Eleven market. This application was made after hearing numerous requests from customers asking why they could not purchase beer and wine at the location and complaining about the inconvenience of not being able to do so. The market completed the 30-day posting requirement for its ABC License on or about March 19th after posting the ABC Notice in a clearly visible location at the front of the store.

As our business is to serve the convenience of our customers, 7-Eleven seeks to now sell a small amount of beer and wine daily between the hours of 6:00 a.m. and 2:00 a.m., as permitted by State law. In order to address any concerns of the neighborhood, this market has agreed to conditions in its ABC License, which are attached as Exhibit 1 and include limitations on the size of beer, malt beverages, and wine that may be sold and also prevents wine from being sold that has an alcohol content greater than 15% by volume. While the sale of alcoholic beverage will be limited as discussed above, the location itself will remain open 24 hours a day, seven days a week.

The issuance of an ABC license to this store will serve the public convenience or necessity of the immediate neighborhood and citywide because it will allow the community to have one-stop shopping for all of their grocery needs. Currently, we sell a full array of grocery products including, but not limited to, milk, cheese, toilet paper, toothpaste, diapers, chips, bread, feminine hygiene products, newspapers, household cleaning products, baked goods, and many other sundries. We receive fresh food deliveries daily and are able to offer our customers prepared foods, fresh fruit, and a coffee bar. With the ability to sell a small amount of beer and wine to complement these grocery items, we can then allow customers to purchase all of their grocery needs at one location, which will serve the public convenience.

To Whom It May Concern:

The Planning Department recommends approval for ABC Type-20 license permitted in conjunction with existing grocery store (d.b.a. 7-Eleven) in C-3-O - Downtown-Office District (Sec. 210.2). Grocery stores holding a Type-20 license may sell beer and wine for consumption off the premises under the condition that **all areas devoted to the display and sale of alcoholic beverages do not exceed 15% of the Occupied Floor Area of the establishment (Sec. 102).**

Such grocery uses are also subject to the following operating conditions of Section 202.2(a)(1):

- (A) The business operator shall maintain the main entrance to the building and all sidewalks abutting the subject property in a clean and sanitary condition in compliance with the Department of Public Works Street and Sidewalk Maintenance Standards. In addition, the operator shall be responsible for daily monitoring of the sidewalk within a one-block radius of the subject business to maintain the sidewalk free of paper or other litter associated with the business during business hours, in accordance with Article 1, Section 34 of the San Francisco Police Code.
- (B) The premises shall be adequately soundproofed or insulated for noise and operated so that incidental noise shall not be audible beyond the premises or in other sections of the building, and fixed-source equipment noise shall not exceed the decibel levels specified in the San Francisco Noise Control Ordinance.
- (C) While it is inevitable that some low level of odor may be detectable to nearby residents and passersby, appropriate odor control equipment shall be installed in conformance with the approved plans and maintained to prevent any significant noxious or offensive odors from escaping the premises.
- (D) Garbage, recycling, and compost containers shall be kept within the premises and hidden from public view and placed outside only when being serviced by the disposal company. Trash shall be contained and disposed of pursuant to garbage and recycling receptacles guidelines set forth by the Department of Public Works.
