9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Kai Kopp v. City and County of San
12 Francisco, et al., San Francisco Superior Court Case No. CGC-16-551183 by the payment
13 of \$40,000. The lawsuit involves an alleged personal injury in a City park.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 March 28, 2016, and the following parties were named in the lawsuit: Plaintiff Kai Kopp; and
16 Defendants SF Latin Baseball League, and City and County of San Francisco.




