4 **and County of San Francisco for \$750,000; the lawsuit was filed on December 28, 2018,**
5 **in San Francisco Superior Court, Case No. CGC-18-572391; entitled Christian Miller v.**
6 **Juan Francisco Ceballos, et al.; the lawsuit involves alleged personal injury from a**
7 **vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Christian Miller v. Juan Francisco
12 Ceballos, et al., San Francisco Superior Court, Case No. CGC-18-572391 by the payment of
13 \$750,000. The lawsuit involves alleged personal injury from a vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 December 28, 2018, and the following parties were named in the lawsuit: plaintiff: Christian
16 Miller; defendants: Juan Francisco Ceballos and City and County of San Francisco.
