

**SUBJECT:** Effects of Golden Gate National Recreation Area's Draft Off-Leash Dog Policy

Supervisor Wiener requests that the Recreation and Parks Department, Animal Care and Control, PUC, DPW and the Port respond to and provide updates on the following topics:

- 1. The Departments' analysis of and response to the Golden Gate National Recreation Area's draft proposal restricting off-leash dogs in Fort Funston, Crissy Field, and other areas, including whether these restrictions will cause an increase in off-leash dogs in City-owned parks and open-spaces and thus lead to increased operating challenges within City-owned parks and open spaces.
- 2. Whether additional resources might be necessary to ensure adequate education, outreach, signage, maintenance and enforcement in light of any possible impact in city-owned parks and open spaces from the GGNRA's draft proposal.
- 3. Whether legislation should be adopted to require permits for commercial dog walkers who walk more than a certain number of dogs at a time in City-owned parks and open spaces.
- 4. Whether Rec & Park has sufficient park police and other enforcement resources to enforce park rules, including rules around littering.
