6 **WHEREAS**, On February 20, 2001, the Parking and Traffic Commission adopted
7 Resolution No. 113-01-PTC authorizing the Director of Property to advertise the Invitation for
8 Bids for the management of the North Beach Garage and the Vallejo Street Garage; and,

9 **WHEREAS**, Eleven (11) parking firms submitted pre-qualification questionnaires and
10 nine (9) firms were qualified to submit bids. On file with the Clerk of the Board of Supervisors
11 in File No. 011389, which is hereby declared to be a part of this resolution as if set
12 forth fully herein; and,

13 **WHEREAS**, Pacific Park Management Incorporated submitted the lowest responsive
14 and responsible bid, after the Human Rights Commission ratings discounts were applied, for
15 the management of the North Beach Garage and the Vallejo Street Garage to Pacific Park
16 Management Incorporated; now, therefore, be it

17 **WHEREAS**, The Parking and Traffic Commission at its meeting of July 17, 2001
18 passed Resolution No. 155-01-PTC, urging the Board of Supervisors to Award the
19 Management Agreement for the North Beach Garage and the Vallejo Street Garage to Pacific
20 Park Management Incorporated; and,

21 **RESOLVED**, That the Board of Supervisors approves the award of the Management
22 Agreement for the North Beach Garage and the Vallejo Street Garage to Pacific Park
23 Management Incorporated; and, be it
