**NOTICE OF PUBLIC HEARING**  
NOTICE IS HEREBY GIVEN that on February 5, 2015, at 9:00 a.m., at the Mayor's Office of Housing and Community Development, 1 South Van Ness Avenue, 5th Floor, San Francisco, California 94103, the City and County of San Francisco (the "City") will conduct a public hearing (the "Public Hearing") at which time the City will hear and consider information concerning the proposed sale and issuance by the City of private activity multifamily affordable housing mortgage revenue bonds (the "Bonds") in an aggregate principal amount up to two hundred million dollars \$200,000,000. All or a portion of the proceeds of the Bonds will be loaned to Related/Mariposa Development Co., LLC, a California limited liability company (or any successor thereto including any successor owner of the Project) (the "Borrower"), pursuant to a loan agreement (the "Loan Agreement"). The proceeds of the Bonds loaned to the Borrower will be used to finance the acquisition and new construction of a mixed-use residential community consisting of approximately 320 residential rental units (20% of the residential units shall be rent-restricted units for households earning less than 50% of the area median income pursuant to the Mayor's Office of Housing and Community Development guidelines) located at 1601 Mariposa Street (Assessor's Parcel Numbers 4005-001B, 4005-004, 4006-006, 4006-010, 4006-019, 4006-020), San Francisco, California 94103, including approximately 10,190 square feet of commercial retail, 277 parking spaces, residential amenities including a fitness center and bicycle workshop, and a public mid-block pedestrian living street (the "Project"). The Project will be owned and operated by the Borrower (or an affiliate thereof or successor thereto).

on the Bonds, nor shall the City, the State or any other political corporation, subdivision or agency of the State be liable or obligated to pay the principal, premium, if any, or interest on the Bonds. The Public Hearing is intended to comply with the public approval requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended. All those interested in matters related to the issuance of the Bonds and to the financing of the Project are invited to attend and be heard at this hearing. Interested parties may appear in person at the time and place indicated above or submit written comments, which must be received prior to the Public Hearing, to the City, c/o Joan McNamara, Mayor's Office of Housing and Community Development, at the address indicated above.
