6 WHEREAS, Charter, Section 13.104.5, prohibits City employees and officers (other
7 than the Director of Elections, Department of Elections employees, Elections Commissioners,
8 the Sheriff and Sheriff’s Department employees) from performing “any function relating to the
9 conduct of an election”; and

10 WHEREAS, Charter, Section 13.104.5, authorizes the Board of Supervisors, upon the
11 request of the Elections Commission, to waive this prohibition by motion; and

12 WHEREAS, On July 21, 2021, the Elections Commission requested that the Board of
13 Supervisors waive this prohibition to permit City employees to assist the Department of
14 Elections with the September 14, 2021, Gubernatorial Recall Election; now, therefore, be it

15 MOVED, That the Board of Supervisors waives the prohibition imposed by Charter,
16 Section 13.104.5, and authorizes City employees to assist the Department of Elections
17 before, during and after the September 14, 2021, Gubernatorial Recall election.
