15       Edwin Wilkerson, seat 7, succeeding himself, term expired, must be a person who  
16 served in the Armed Forces of the United States of America and who have a physical  
17 disability arising from that service, in accordance with the definitions applied in such cases by  
18 the Veterans' Administration, for the unexpired portion of a four-year term ending January 31,  
19 2015.

20       Stephen Noetzel, seat 8, succeeding himself, term expired, must be an at-large  
21 appointment, for the unexpired portion of a four-year term ending January 31, 2015.

22       Regaldo Baldonado, seat 11, succeeding himself, term expired, must be an at-large  
23 appointment, for the unexpired portion of a four-year term ending January 31, 2015.
