3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine**  
4 **public premises license to Bakhshish Kaur, for San Francisco Comedy Club**  
5 **located at 50 Mason Street, will serve the public convenience and necessity of the**  
6 **people of the City and County of San Francisco, in accordance with Section**  
7 **23958.4 of the California Business and Professions Code, with conditions.**

9 WHEREAS, Bakhshish Kaur is seeking issuance of a Type 42 on-sale beer and  
10 wine public premises license for San Francisco Comedy Club, located at 50 Mason  
11 Street; and,

12 WHEREAS, The City Planning Department has verified that the area is properly  
13 zoned; and

14 WHEREAS, The Police Department recommends that the liquor license  
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business  
17 and Professions Code, the Board of Supervisors of the City and County of San  
18 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
19 on-sale beer and wine public premises license, to Bakhshish Kaur for San Francisco  
20 Comedy Club, located at 50 Mason Street will serve the public convenience and  
21 necessity of the people of the City and County of San Francisco.

22 Conditions: (1) No noise shall be audible beyond the area under control of the  
23 licensee; (2) Petitioners shall not permit their patrons or the general public to loiter or  
24 congregate on the sidewalks adjacent to the licensed premises; (3) The petitioner(s)  
25 shall be responsible for maintaining free of litter the area adjacent to the premises over

1 which they have control; (4) The premises shall operate primarily as a comedy club with  
2 incidental sales of beer and wine allowed only on performance nights; (5) Sales and  
3 service of alcoholic beverages shall be permitted only between the hours of 5:00 p.m. to  
4 2:00 a.m. Wednesday through Saturday; (6) The sale of alcoholic beverages for  
5 consumption off premises is strictly prohibited; (7) Petitioners shall not permit nude or  
6 topless entertainment, or lingerie type shows; (8) Petitioners shall not permit pool or  
7 billiard tables, or any coin operated games or video machines on the premises; (9)  
8 Petitioner shall not maintain or construct private viewing room(s) intended for use by  
9 patrons.


