3	Resolution honoring the outstanding service of Catherine Stefani, Supervisor for San
4	Francisco District 2, and declaring November 19, 2024, as Supervisor Catherine Stefani
5	Day in the City and County of San Francisco.
6	
7	WHEREAS, Supervisor Catherine Stefani has demonstrated an exceptional
8	commitment to public service, beginning her career as a prosecutor for the Office of the
9	Contra Costa County District Attorney; and
10	WHEREAS, She has a history of distinguished service, including roles with San Jose
11	Vice Mayor Cindy Chavez, the California Department of Justice, and California Assembly
12	Speaker Herb Wesson, for whom she analyzed bills for the Assembly Democratic Caucus;
13	and
14	WHEREAS, Supervisor Stefani would go on to work as a senior Legislative Aide to
15	District 2 Supervisors Michela Alioto-Pier and Mark Farrell; and
16	WHEREAS, In 2016, Mayor Edwin M. Lee appointed her as San Francisco County
17	Clerk, a position in which she initiated the practice of marrying hundreds of LGBTQ+ couples
18	at City Hall on the Friday before San Francisco Pride, a tradition that has since become a
19	powerful symbol of the City's unwavering dedication to equality; and
20	WHEREAS, In 2018, Supervisor Stefani was appointed by Interim Mayor Farrell to
21	represent District 2 on the Board of Supervisors, serving a vibrant array of neighborhoods,
22	including the Marina, Cow Hollow, Pacific Heights, Anza Vista, Laurel Village, and the
23	Presidio; and

2	contested election for a full term in 2018, and her unopposed re-election in 2022 reflects the
3	widespread respect and confidence she has garnered throughout District 2; and
4	WHEREAS, During her tenure on the Board, Supervisor Stefani has been a tireless
5	advocate for her 80,000 constituents, passing groundbreaking legislation including the
6	establishment of a centralized Office of Victims' Rights, championing one of the state's first
7	bans on untraceable ghost guns, entitling thousands of homes in District 2, and strengthened
8	accountability standards for nonprofit organizations receiving city funds; and
9	WHEREAS, Her leadership has extended across several key roles on the Board of
10	Supervisors, including Chair of the Public Safety and Neighborhood Services Committee, Vice
11	Chair of the Government Audit and Oversight Committee, and membership on the Budget and
12	Finance Committee, Rules Committee, Behavioral Health Board, Family Violence Council,
13	Golden Gate Bridge Board, and the Reentry Council; and
14	WHEREAS, As Chair of the Public Safety and Neighborhood Services Committee,
15	Supervisor Stefani has prioritized public safety by supporting the resources and efficacy of the
