

7 WHEREAS, San Francisco Charter section 13.104.5 prohibits City employees and  
8 officers (other than the Director of Elections, an appointee of the Director of Elections or a  
9 member of the Elections Commission) from performing “any function relating to the conduct of  
10 an election;” and,

12 WHEREAS, Charter section 13.104.5 authorizes the Board of Supervisors, upon the  
13 request of the Elections Commission, to waive this prohibition by motion; and,

15 WHEREAS, On April 21, 2010, the Elections Commission requested that the Board of  
16 Supervisors waive this prohibition to permit City employees to assist the Department of  
17 Elections with the June 8, 2010 election; now, therefore, be it

18 MOVED, the Board of Supervisors waives the prohibition imposed by Charter section  
19 13.104.5, to permit City employees to assist the Department of Elections before, during and  
20 after the June 8, 2010 election.
