3 WITH THE FRIENDS OF SUNNYSIDE CONSERVATORY AND SAN FRANCISCO CITY  
4 COLLEGE ON A PARTNERSHIP TO RESTORE AND REHABILITATE THE SUNNYSIDE

7 WHEREAS, The Sunnyside Conservatory is a landmark in the City  
8 and County of San Francisco treasured by the neighborhood; and,

9 WHEREAS, Over the years, the Sunnyside Conservatory has fallen  
10 into disrepair, plagued by problems such as poor irrigation, invasive  
11 plants, vandalism, graffiti, and gang activity; and,

12 WHEREAS, A group of dedicated neighbors who had voluntarily been  
13 tending to the Conservatory came together to form the Friends of  
14 Sunnyside Conservatory in 1999; and,

15 WHEREAS, San Francisco City College Horticulture Department's  
16 Center for Habitat Restoration has made a commitment to work with the  
17 Friends of Sunnyside Conservatory to address environmental concerns,  
18 link restoration projects with volunteers, and promote environmental  
19 education by helping to design and implement an environmental  
20 curriculum; and,

21 WHEREAS, The Department of Recreation and Parks recently forged  
22 a partnership with the Friends of Sunnyside Conservatory and the City  
23 College Horticulture Department to identify needs and design a plan  
24 for rehabilitation and restoration of the Sunnyside Conservatory; now  
25 therefore be it,


