8 the Bureau of Streets Environmental Services before recently announcing her retirement; and,

9 WHEREAS, After successfully turning her passion for gardening into a career with the
10 City and County of San Francisco working for the Department of Parks and Recreation and
11 the Strybling Arboretum Society, Chris Ellen Montgomery quickly advanced through the
12 Department of Public Works in several supervisory roles; and,

13 WHEREAS, In 2000, Chris Ellen Montgomery was selected as the Assistant Manager
14 of Urban Forestry where she was instrumental in directing field operations as well as
15 responding to citizens' concerns and helping to establish Clean Team projects; and,

16 WHEREAS, Chris Ellen Montgomery was promoted to Assistant Superintendent of the
17 Bureau of Streets Environment Services where she was directly responsible for the handling
18 of the Bureau's budget, personnel, office staff, graffiti unit and 28Clean as well as securing a
19 two hundred and eighty percent increase in funding for street events and managing the
20 Mechanical Sweeping program, Dispatch and Night Operations; and,

21 WHEREAS, During an important transition period for the Bureau of Streets
22 Environmental Services, Chris Ellen Montgomery served as the bureau's Acting
23 Superintendent, helping to smooth the transition to a new superintendent in addition to
24 assisting in the training the new Assistant Superintendent of Operations and handling all
