5 WHEREAS, Patti Chang has recently been granted a Special Recognition by the Commission
6 on the Status of Women in the 8th Annual Women Who Make a Difference awards; and,

7 WHEREAS, The Commission on the Status of Women's "Women Who Make a Difference
8 Awards" honor distinguished women from the private and public sector and businesses throughout San
9 Francisco who, in the areas of employment and economic advancement, make a positive difference in
10 women's lives; and

11 WHEREAS, Patti Chang has an outstanding record of achievements and activism on behalf of
12 women's employment and economic advancement; and

13 WHEREAS, Patti Chang is the President and Chief Executive Officer of the Women's
14 Foundation; and

15 WHEREAS, the Women's Foundation has launched a five million, five year Initiatives Forum
16 statewide campaign to focus grant making and organizing activities around women's health and pay
17 issues; and

18 WHEREAS, the Women's Foundation is establishing a donor advised fund to address economic
19 development and justice for women; and

20 WHEREAS, Patti Chang was a member of the San Francisco Commission on the Status of
21 Women from 1992 to 1999 and served as president from 1997 through 1999; and

22 WHEREAS, Patti Chang chaired task forces on Adult Sexual Assault and on the Convention to
23 Eliminate All Forms of Discrimination Against Women; and

24 WHEREAS, Patti Chang was the program Co-Chair of the San Francisco Mayor's Women's
25 Summit held in April 1999 and was on the executive planning committee for the 2000 summit; and

1 WHEREAS, Patti Chang is on the Advisory Board of the Women’s Institute for Leadership
2 Development and the Board of Directors of Planned Parenthood Golden Gate, the International

4 WHEREAS, Patti Chang is a member of the Working Group on funding Lesbian and Gay Issues
5 through the Council on Foundations and is a founding member of the Women’s Leadership Alliance;

7 WHEREAS, Patti Chang was a fellow of the Asian Pacific American Women Leadership
8 Institute and has received awards from the Pacific Asian American Women of the Bay Area Coalition
9 and the National Women’s Political Caucus; therefore be it

10 RESOLVED, that the Board of Supervisors of the City and County of San Francisco commends
11 Patti Chang for her outstanding achievements in her advocacy of women’s rights; and therefore be it

12 FURTHER RESOLVED, that the Board of Supervisors of the City and County of San Francisco
