6 **3:18-cv-00634-SI; entitled Sean Moore v. City and County of San Francisco, et al.; the**
7 **lawsuit involves claims of civil rights violations and use of excessive force.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Sean Moore v. City and County of San
12 Francisco, et al., United States District Court for the Northern District of California, Case No.
13 3:18-cv-00634-SI by the payment of \$3,250,000. The lawsuit involves claims of civil rights
14 violations and use of excessive force.

15 Section 2. The above-named action was filed in United States District Court for the
16 Northern District of California on January 29, 2018, and the following parties were named in
17 the lawsuit: plaintiff: Sean Moore; defendants: City and County of San Francisco, Kenneth
18 Cha, Colin Patino.
