

1 [Liquor License Transfer - 168-186 Eddy Street - Dalda's Market]

3 **Resolution determining that the premise-to-premise transfer of a Type-21 off-sale**  
4 **general beer, wine, and distilled spirits liquor license to Dalda's Inc., doing**  
5 **business as Dalda's Market, located at 168-186 Eddy Street (District 6), will serve**  
6 **the public convenience or necessity of the City and County of San Francisco, in**  
7 **accordance with California Business and Professions Code, Section 23958.4; and**  
8 **requesting that the California Department of Alcoholic Beverage Control impose**  
9 **conditions on the issuance of the license.**

11 WHEREAS, Dalda’s Inc. is seeking the premise-to-premise transfer of a Type-21  
12 off-sale general beer, wine, and distilled spirits liquor license, to do business as Dalda’s  
13 Market located at 168-186 Eddy Street (District 6); and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed four protests and zero letters of  
17 support with the Department of Alcoholic Beverage Control under California Business  
18 and Professions Code, Section 24013, and recommends that the Department of  
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department, as  
21 documented on the applicant’s signed form ABC-172 dated May 16, 2019, are the  
22 following: 1) Sales, service and consumption of alcoholic beverages shall be permitted  
23 only between the hours of 7:00 a.m. and 12:00 a.m. each day of the week; and 2)  
24 Petitioner(s) shall actively monitor the area under their control in an effort to prevent the

1 loitering of persons on any property adjacent to the licensed premises as depicted on  
2 the ABC-253; now, therefore, be it

3           RESOLVED, That in accordance with California Business and Professions Code,  
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
5 hereby determines that the transfer of a Type-21 off-sale general beer, wine, and  
6 distilled spirits liquor license to Dalda's Inc., doing business as Dalda's Market, located  
7 at 168-186 Eddy Street (District 6), will serve the public convenience or necessity of the  
8 City and County of San Francisco; and, be it

9           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
10 San Francisco hereby endorses and adopts the recommendations of the Police  
11 Department listed above and recommends that the Department of Alcoholic Beverage  
12 Control issue the license with those conditions.
