3 **Resolution authorizing the Department of the District Attorney of the City and County**
4 **of San Francisco to accept and expend a grant in the amount of \$64,500 from the**
5 **Kaiser Permanente Northern California Community Grants Program for a program**
6 **entitled “Back on Track” for fiscal year 2007/2008.**

8 WHEREAS, The City and County of San Francisco desires to continue a certain project
9 designated the Back on Track Program to be funded in part from funds made available from
10 the Kaiser Permanente Northern California Community Grants Program (hereafter “Kaiser
11 Permanente”); and,

12 WHEREAS, the grant does not require an ASO amendment; therefore, be it

13 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of
14 the City and County of San Francisco to accept and expend funds from Kaiser Permanente
15 for the purposes of its Back on Track Program; and, be it

16 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
17 indirect costs in the grant budget; and be it

18 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of
19 the City and County of San Francisco the necessary Grant Award Agreements for Back on
20 Track Program purposes, including any extensions, augmentations or amendments thereof;
21 and be it

22 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
23 execute, deliver and perform, in the name of the City and County of San Francisco, all
24 applications, contracts, agreements, amendments and payment requests necessary for the



5 Award Agreement, including civil court actions for damages, shall be the responsibility of the
6 grant recipient and the authorizing agency; and that the grant recipient and the authorizing
7 agency will hold Kaiser Permanente harmless from any claims that may arise from the use of
8 grant funds; be it

9 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
10 supplant expenditures controlled by this body.




