14 has been instrumental in the development of adult basic education, literacy, high school and

16 WHEREAS, Ms. Schultz has shared her professional expertise generously by training  
17 staffs of other organizations in the Bay Area and throughout the West Coast; and,

18 WHEREAS, After 30 years of dedicated services to the students of City College of San  
19 Francisco, Ms. Schultz is now retiring; and,

20 WHEREAS, Her exemplary work will continue to have a lasting effect on future  
21 students and educators in the pursuit of promoting educational and social goals; now  
22 therefore, be it,

23 RESOLVED, That the San Francisco Board of Supervisors commend Gabriella Schultz  
24 for her tireless commitment to her students, her school, and to the community, and wish her  
25 luck in her future endeavors.


