5 RESOLVED, That, in accordance with the provisions of the California Vehicle
6 Code and the San Francisco Traffic Code, the following regulations governing the
7 parking of vehicles are hereby enacted or rescinded as designated below:

8 **RESIDENTIAL PERMIT PARKING AREA "S" (TWO-HOUR TIME LIMIT, 8 AM - 9 PM,
9 MONDAY THROUGH FRIDAY) - ESTABLISH**

10 20th Street, both sides, between Church and Sanchez Streets (3900 block).

11 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

12 Fell Street, south side, from 167.5 feet to 171 feet west of Divisadero Street (in
13 front of 1217 - 1221 Fell Street, accommodates one unmetered
14 motorcycle parking stall)

15 Categorically exempt from
16 Environmental Review Class 1(c)(9)
17 changes in the traffic and parking
18 regulations where such changes do not
19 establish a higher speed limit or result in
20 more than a negligible increase in the
21 use of the street.
