3 **Resolution adopting Local Goals and Policies for Mello-Roos Community Facilities**

6 WHEREAS, Under the Mello-Roos Community Facilities Act of 1982, as amended,
7 constituting Sections 53311 *et seq* of the California Government Code (the "Act"), local
8 agencies may form a community facilities district for the purpose of financing community
9 facilities and/or services; and,

10 WHEREAS, The Act requires a local agency to adopt local goals and policies
11 applicable to the formation of community facilities districts as a prerequisite to instituting
12 proceedings for the formation of such a district; and,

13 WHEREAS, A document setting forth a proposed set of local goals and policies for the
14 formation of community facilities districts within the City and County of San Francisco (the
15 "Local Goals and Policies") is on file with the Clerk of the Board of Supervisors in File
16 No. 090939, which is hereby declared to be a part of this Resolution as if set forth
17 fully herein; now, therefore, be it

18 RESOLVED, That this Board of Supervisors hereby finds that the Local Goals and
19 Policies meet the requirements of the Act and are hereby adopted by the Board of
20 Supervisors for purposes of compliance with the Act; and, be it

21 FURTHER RESOLVED, That such Local Goals and Policies may be subject from time
22 to time to amendment by resolution of this Board of Supervisors; and, be it


23 FURTHER RESOLVED, That this Resolution and the Local Goals and Policies shall be
