10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Siobhan McAuliffe v. City & County of
13 San Francisco, San Francisco Superior Court, Case No. 12-524514, by the payment of
14 \$250,000.

15 Section 2. The above-named action was filed in United States District Court for the
16 Northern District of California, Case No. CV-12-00071 CRB, and then re-filed in San
17 Francisco Superior Court on September 20, 2012, and the following parties were named in
18 the lawsuit: Plaintiff Siobhan McAuliffe and Defendant City & County of San Francisco.


