4 **A Residential Condominium Project, being a subdivision of Lot 235 in Assessor's**  
5 **Block No. 4991, accepting the offer of dedication of public improvements subject to**  
6 **completion, approving a public improvement agreement and adopting findings pursuant**  
7 **to Planning Code Section 101.1.**

9       MOVED, That the certain map entitled "Map of St. Francis Bay Condominiums,  
10 1 Crescent Way, A Residential Condominium Project", being a subdivision of Lot 235,  
11 Portion of Assessor's Block No. 4991, comprising 8 sheets, approved the 12<sup>th</sup> day of  
12 March, 2003 by Department of Public Works Order No. 174,007, be and the same is hereby  
13 approved and adopted as the Official Map of "St. Francis Bay Condominiums, 1 Crescent  
14 Way, A Residential Condominium Project".

15       FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own  
16 and incorporates by reference herein as though fully set forth the findings made by the  
17 Planning Department, by its letter dated May 16, 2001, that the project intended by the  
18 map is consistent with the General Plan and the Priority Policies of Planning Code Section  
19 101.1.

20       FURTHER MOVED, That because the subdivider has not completed the construction  
21 of required public improvements at this time, the Board of Supervisors, pursuant to  
22 California Government Code Section 66462, acknowledges and approves the St. Francis  
23 Bay Public Improvement Agreement, which is attached hereto and incorporated herein by  
24 reference. A copy of said Agreement and accompanying public improvement plans are on  
25 file with the Clerk of the Board of Supervisors in File No. 031379.


1 FURTHER MOVED, The Board of Supervisors acknowledges and accepts, subject to


