3 **Ordinance authorizing settlement of the lawsuit filed by Margaret Hardgrave against the**  
4 **City and County of San Francisco for \$75,000; the lawsuit was filed on**  
5 **November 14, 2018, in San Francisco Superior, Case No. CGC-18-571308; entitled**  
6 **Margaret Hardgrave v. Ramallah Club, Incorporated, et al.; the lawsuit involves alleged**  
7 **personal injury on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Margaret Hardgrave v. Ramallah Club,  
12 Incorporated, et al., San Francisco Superior Court, Case No. CGC-18-571308 by the payment  
13 of \$75,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 November 14, 2018, and the following parties were named in the lawsuit: plaintiff: Margaret  
16 Hardgrave; defendants: Ramallah Club, Incorporated and City and County of San Francisco.
