8 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) has taken a
9 leadership role in the resolution of issues surrounding Lake Merced and the Westside Basin
10 groundwater aquifer; and

11 WHEREAS, The SFPUC, the City of San Bruno and other users of the Westside Basin
12 have reached agreement on conducting a study to determine the feasibility of using available
13 storage space in the Westside Basin aquifer for the benefit of the SFPUC water system, with
14 corresponding benefits to management of Lake Merced water levels; and

15 WHEREAS, the SFPUC approved the proposed First Amendment to Water Supply
16 Contract with San Bruno in Resolution No. 02-0199 dated September 24, 2002; and

17 WHEREAS, The First Amendment to the Water Supply Contract Between the City and
18 County of San Francisco and the City of San Bruno for Purposes of Conducting an Aquifer
19 Recharge Study is on file with the Clerk of the Board of Supervisors in
20 File No. 021666, which is hereby declared to be a part of this resolution as if set
21 forth fully herein; and

22 WHEREAS, The contract amendment for conducting the aquifer recharge study is
23 categorically exempt under CEQA, State Guidelines, Section 15306, Class 6, Information
24 Collection; now therefore be it

1 RESOLVED, That the Board of Supervisors approves the terms and conditions
2 contained in the First Amendment to the Water Supply Contract Between the City and County
3 of San Francisco and the City of San Bruno for Purposes of Conducting an Aquifer Recharge
4 Study; and be it

5 FURTHER RESOLVED, that the Board of Supervisors authorizes the SFPUC General
6 Manager to sign the First Amendment to the Water Supply Contract Between the City and
7 County of San Francisco and the City of San Bruno for Purposes of Conducting an Aquifer
8 Recharge Study.
