The SFPUC, the City of San Bruno and other users of the Westside Basin have reached agreement on conducting a study to determine the feasibility of using available storage space in the Westside Basin aguifer for the benefit of the SFPUC water system, with corresponding benefits to management of Lake Merced water levels; and

WHEREAS, the SFPUC approved the proposed First Amendment to Water Supply Contract with San Bruno in Resolution No. 02-0199 dated September 24, 2002; and

WHEREAS. The First Amendment to the Water Supply Contract Between the City and County of San Francisco and the City of San Bruno for Purposes of Conducting an Aquifer Recharge Study is on file with the Clerk of the Board of Supervisors in which is hereby declared to be a part of this resolution as if set File No. forth fully herein; and

WHEREAS, The contract amendment for conducting the aquifer recharge study is categorically exempt under CEQA, State Guidelines, Section 15306, Class 6, Information Collection; now therefore be it

RESOLVED, That the Board of Supervisors approves the terms and conditions contained in the First Amendment to the Water Supply Contract Between the City and County of San Francisco and the City of San Bruno for Purposes of Conducting an Aquifer Recharge Study; and be it

FURTHER RESOLVED, that the Board of Supervisors authorizes the SFPUC General Manager to sign the First Amendment to the Water Supply Contract Between the City and County of San Francisco and the City of San Bruno for Purposes of Conducting an Aquifer Recharge Study.
