3 **Resolution commending Kevin Scott Dickey for eight years of exemplary public service**  
4 **to San Francisco as a Deputy City Attorney, and wishing him well in his future**  
5 **endeavors at Meyers Nave Riback Silver & Wilson.**

7 WHEREAS, The Board of Supervisors of the City and County of San Francisco wishes  
8 to honor Kevin Scott Dickey, who has given eight years of dedicated and exemplary public  
9 service to San Francisco as a Deputy City Attorney, first under City Attorney Louise H. Renne  
10 and then under City Attorney Dennis J. Herrera, and who is now leaving the City Attorney's  
11 Office to continue representing public entities at the law firm of Meyers Nave Riback Silver &  
12 Wilson; and

13 WHEREAS, in March 1997, Mr. Dickey joined the City Attorney's Office, having  
14 graduated from the University of San Francisco School of Law and done his undergraduate  
15 work at the University of California at Berkeley; and

16 WHEREAS, Mr. Dickey has been one of the City's best and most effective lawyers,  
17 successfully representing the City in twenty-seven court victories, including ten victories at the  
18 California Court of Appeal, and one at the California Supreme Court; and,

19 WHEREAS, as a Deputy City Attorney and litigator on the City Attorney's Government  
20 Team, Mr. Dickey has successfully litigated important City issues such as the allocation of  
21 sales tax paid on sales of jet fuel negotiated in the City, claims of political opinion  
22 discrimination brought by City employees, challenges to the legality and application of the  
23 City's Rent Ordinance and of the regulations of the San Francisco Residential Rent  
24 Stabilization and Arbitration Board, and constitutional challenges to the City's prohibition  
25 against write-in candidates at runoff elections; and,

1           WHEREAS, Mr. Dickey has distinguished himself among his peers, excelling in oral  
2 arguments and crafting sophisticated and powerful briefs, and

3           WHEREAS, Mr. Dickey's colleagues in the City Attorney's Office have valued him for  
4 his legal and analytical skills, his extensive knowledge of often arcane legal procedures, his  
5 diligence and thoroughness, his extraordinarily hard work, the seriousness with which he took  
6 his commitment to public service, his unstinting willingness to assist his colleagues whenever  
7 and in whatever manner necessary, his companionship, his energy, his hearty sense of  
8 humor, and his enthusiasm; now, therefore, be it

9           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
10 hereby commends Kevin Scott Dickey for his eight years of exemplary service for the City and  
11 County; and, be it

12           FURTHER RESOLVED, That the Board of Supervisors wishes him well in his future  
13 endeavors at Meyers Nave Riback Silver & Wilson.




