

[Opposing Consumer Bailout]

1 RESOLUTION OPPOSING ANY PROPOSED "CONSUMER BAILOUTS" AND ANY
2 ELECTRIC RATE INCREASES, AND FURTHER REQUESTS GREATER COMMUNITY
3 INPUT AT THE CALIFORNIA PUBLIC UTILITIES COMMISSION, AS WELL AS A
4 COMMITMENT BY THE CALIFORNIA PUBLIC UTILITIES COMMISSION TO ENHANCE ITS
5 LOW-INCOME PROGRAMS TO ENSURE THAT ALL ELIGIBLE LOW-INCOME
6 CUSTOMERS OF PG&E HAVE WEATHERIZATION AND ARE PART OF THE PRESENT
7 CARE PROGRAM.

8 WHEREAS, the California Public Utilities Commission is a constitutionally created State
9 agency charged with regulating providers of essential services such as electricity, natural gas,
10 water, and telecommunications under the general direction of the State Legislature; and

11 WHEREAS, the California Public Utilities Commission created the blueprint for electric
12 restructuring intent on lowering consumer energy rates; and

13 WHEREAS, AB 1890 promised consumers a 20% rate reduction, via a mandated 10%
14 automatic reduction and a 10% reduction naturally occurring through competition; and

15 WHEREAS, San Diego Gas and Electric was the first utility to open up to competition
16 and end a freeze on rates causing citizens of San Diego to pay, on average, a 270% increase
17 in electric rates; and

18 WHEREAS, Pacific Gas and Electric and Southern California Edison are seeking a
19 consumer "bail out" for their increased wholesale electricity prices; and

20 WHEREAS, the end of the rate freeze is likely to double or triple electric rates and bills;
21 and

22 WHEREAS, the average low-income consumer pays 10% or more of their total income
23 for energy consumption and needs additional ratepayer assistance and energy efficiency
24 programs to ensure access to affordable electricity; and

25 WHEREAS, the California Public Utilities Commission has rejected mechanisms to
ensure sustained community input; and

1 WHEREAS, the California Public Utilities Commission has so far failed to devise any
2 effective methods for protecting seniors, working families, disabled, limited-English speakers
3 and the poor from excessive rate increases; and

4 WHEREAS, it is the desire of the City and County of San Francisco to protect
5 businesses in San Francisco, senior citizens, disabled individuals, low-income residents as
6 well as working-class families from excessive energy rate increase; therefore be it

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 opposes any proposed "consumer bailouts" and any electric rate increases, and requests
9 greater community input at the California Public Utilities Commission, as well as a commitment
10 by the California Public Utilities Commission to enhance its low-income programs to ensure
11 that all eligible low-income customers of PG&E have weatherization and are part of the present
12 CARE program.


