3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**  
4 **and expend retroactively a grant in the amount of \$32,249 from the Chinese**  
5 **Progressive Association for a project entitled “Worker Health and Safety in Chinatown**  
6 **Restaurants,” for the period of August 1, 2008 through July 31, 2010.**

8 WHEREAS, The Chinese Progressive Association is the recipient of a grant from The  
9 ~~California Endowment to fund a project entitled “Worker Health and Safety in Chinatown~~  
10 ~~Restaurants;” and,~~

11 WHEREAS, The Chinese Progressive Association is funding DPH’s Environmental  
12 Health Section (EHS) in the amount of \$32,249 to assist with this project, for the period of  
13 August 1, 2008 through July 31, 2010; and,

14 WHEREAS, This project is a collaboration between DPH-EHS, Chinese Progressive  
15 Association, the Department of Occupational Medicine at UCSF, and the School of Public  
16 Health/Labor Occupational Program at University of California Berkeley, with UC Berkeley  
17 leading the project; and,

18 WHEREAS, This project will support advocacy, education and changes in the physical  
19 work environment through the partnership approach to improving health and safety for low  
20 income immigrant, restaurant workers in the Chinatown area of San Francisco; and,

21 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH  
22 for one existing position, Health Program Coordinator I (Job Class #2589) at .15 FTE, for the  
23 period of August 1, 2008 through July 31, 2010; and,

24 WHEREAS, The budget includes a provision for indirect costs of \$3,564;

9 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
10 agreement on behalf of the City; and, be it


11 FURTHER RESOLVED, That the Controller is directed to designate all positions
