1 [ETHIOPIA, ERITREA, SIERRA LEONE AND SANKOH'S REVOLUTIONARY UNITED  
FRONT REBELS]

2 RESOLUTION URGING THE UNITED NATIONS, THE STATE DEPARTMENT, AND  
3 PRESIDENT BILL CLINTON TO NEGOTIATE A SETTLEMENT BETWEEN ETHIOPIA &  
4 ERITREA AS WELL AS BETWEEN SIERRA LEONE AND SANKOH'S  
5 REVOLUTIONARY UNITED FRONT REBELS IN THE HOPES OF ENDING THE  
CONFLICT, VIOLENCE, DESTRUCTION AND FAMINE.

6 WHEREAS, Ethiopia and Eritrea have been at war for 2 years over a 620 mile  
7 border; and,

8 WHEREAS, Ethiopia continues to attack Eritrean territory even after it has agreed to  
9 resume peace talks; and,

10 WHEREAS, Approximately 60,000 Ethiopians have died since Ethiopia invaded  
11 Eritrea and it is estimated that Eritrea has suffered even more casualties; and,

12 WHEREAS, In Sierra Leone, United Nations and human rights officials believe that  
13 Sankoh's Revolutionary United Front rebels continue to carry out killings and rapes in parts  
14 of Sierra Leone that remain under their control; and,

15 WHEREAS, Approximately 100 UN hostages are still being held by the rebels; and,

16 WHEREAS, The rebels have demanded Foday Sankoh's freedom; now, therefore be it

17 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
18 urges the United Nations, the State Department, and President Bill Clinton to negotiate a  
19 settlement between Ethiopia and Eritrea as well as between Sierra Leone and Sankoh's  
20 Revolutionary United Front rebels in the hopes of ending the conflict, violence, destruction,




