Resolution authorizing the Human Rights Commission to accept and expend a grant in the amount of \$26,000 from the Friends of the Human Rights Commission for the development of an internal database and external searchable web application for the purpose of gathering, sorting and displaying information on insurance companies throughout the United States that offer domestic partner insurance products.

WHEREAS, The City and County of San Francisco requires its contractors to comply with S.F. Admin. Code Chapter 12B, which requires that contractors provide the same benefits to employees with spouses and employees with domestic partners; and,

WHEREAS, to facilitate compliance with this contracting requirement the Human Rights Commission has collected and posted on the City's web site information on insurance providers willing to sell insurance policies inclusive of domestic partner coverage; and,

WHEREAS, this information is woefully out of date; and,

WHEREAS, a database and searchable web application is needed in order to collect and display updated information on insurers offering domestic partner coverage; and,

WHEREAS, the Human Rights Commission proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That the Board of Supervisors agrees to accept and expend the proposed grant; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget.






