3 **Ordinance amending Chapter 2A of Part One of the San Francisco Municipal Code**
4 **(Administrative Code), to add Article XV section 2A.232 establishing the Department of**
5 **Children, Youth and Their Families, enumerating the duties of the Department and**
6 **incorporating within Section 2A.232 the duties of the Department as established in**
7 **other Sections of the Administrative Code; amending and renumbering Section 3.50**
8 **regarding the reporting of allocation of funds and services by gender; and by repealing**
9 **Section 3.50 of Part One of the San Francisco Municipal Code (Administrative Code).**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Section 1. Chapter 2A of the San Francisco Administrative Code is hereby
16 amended by adding Article XV Section 2A.232 to read as follows:

17 ***SEC. 2A.232 DEPARTMENT OF CHILDREN, YOUTH, AND THEIR FAMILIES.***

18 *(a) Department of Children, Youth, and Their Families; Director. There shall be a*
19 *Department of Children, Youth, and Their Families. The Mayor shall appoint a Director who shall*
20 *serve as Department head and appointing officer for the Department. The Director shall serve at the*
21 *pleasure of the Mayor. The Department shall include such officers and employees as are authorized*
22 *pursuant to the budgetary and fiscal provisions of the Charter.*

23 *(b) Duties and Functions. The Department shall be responsible for promoting the*
24 *development of comprehensive programs, policies and planning strategies to enhance services for*
25 *children, youth and their families; and:*

1 (1) *The Department shall assist the Mayor in preparation and implementation of the Children*
2 *Services Plan and Fund as described in Charter Section 16.108.*

3 (2) (A) *Beginning after July 1, 2001, the Department shall report to the Board of Supervisors in*
4 *the Community Needs Assessments required by Charter Section 16.108:*

5 *(i) the number of male and female minors served by recipients of the Children's Fund grants; (ii) the*
6 *comparative monetary value of the expenditure of Children's Fund moneys on male and female minors,*
7 *based on the information collected in subsection (b)(2)(A)(i); and (iii) to the extent data are available,*
8 *the Department shall calculate the percentage of San Francisco's population of female minors who are*
9 *served by the Children's Fund and the percentage of San Francisco's population of male minors who*
10 *are served by the Children's Fund.*

11 (B) *Provisions of this Subsection shall take effect only if Proposition D on the November, 2000*
12 *ballot is enacted.*

13 (3) *Pursuant to Section 86.1 of the San Francisco Administrative Code, the Department shall*
14 *provide office space, administrative support, and other services for the Children and Families*
15 *Commission and its Department, as specified in a Memorandum of Understanding between the*
16 *Department and the Children and Families Commission.*

17 (4) *Pursuant to Section 5.200 of the San Francisco Administrative Code, the Department shall*
18 *provide administrative support for the San Francisco Child Care Planning and Advisory Council.*

19 (5) *The Department shall have such other duties and functions as are assigned by Charter or*
20 *ordinance.*

22 Section 2. Chapter 3 of the San Francisco Administrative Code is hereby amended by
23 repealing section 3.50, as follows:

3 ~~—— (a) — Beginning July 1, 1996, the Mayor's Office of Children, Youth and Families shall report~~
4 ~~to the Board of Supervisors (i) the allocation of funds by all departments and agencies of the City and~~
5 ~~County of San Francisco for services rendered to young males and females under 18 years of age and~~
6 ~~(ii) the amount of the actual services rendered by such City departments and agencies to young males~~
7 ~~and females under 18 years of age. Such report shall be submitted annually by July 1st of each year~~
8 ~~and cover the period of the prior calendar year.~~

9 ~~—— (b)(1) The report shall identify the disparity or disparities, if any, in the allocation of funds to~~
10 ~~young males and young females under 18 years of age by calculating the ratio of the amount of~~
11 ~~allocated funds to males under 18 years of age to the total amount of allocated funds to all males and~~
12 ~~females under 18 years of age and the ratio of the amount of allocated funds to females under 18 years~~
13 ~~of age to the total amount of allocated funds to all males and females under 18 years of age. If the~~
14 ~~report identifies a disparity or disparities in the allocation of funds, the report shall set forth a detailed~~
15 ~~plan of action to resolve such disparity or disparities.~~

16 ~~—— (2) The report shall identify the disparity or disparities, if any, in the amount of the actual~~
17 ~~services rendered to young males and young females under 18 years of age by calculating the ratio of~~
18 ~~the amount of the actual services rendered to males under 18 years of age to the total amount of the~~
19 ~~actual services rendered to all males and females under 18 years of age and the ratio of the amount of~~
20 ~~the actual services rendered to females under 18 years of age to the total amount of actual services~~
21 ~~rendered to all males and females under 18 years of age. If the report identifies a disparity or~~
22 ~~disparities in the amount of the actual services rendered, the report shall set forth a detailed plan of~~
23 ~~action to resolve such disparity.~~




