3 **Resolution supporting House of Representatives Joint Resolution expressing the**  
4 **Sense of Congress and HR: 2888 the "2001 Emergency Supplemental Appropriations**  
5 **Act for Recovery from and Response to Terrorist Attacks of the United States"**  
6 **appropriating \$40,000,000,000 for emergency expenses to respond to the terrorist**  
7 **attacks on the United States**

9 WHEREAS, on September 11<sup>th</sup>, 2001, terrorists hijacked and destroyed four civilian  
10 aircraft, crashing two of them into the towers of the World Trade Center in New York City, and  
11 a third into the Pentagon outside Washington, D.C.; and

12 WHEREAS, thousands of innocent Americans were killed and injured as a result of  
13 these attacks, including the passengers and crew of the four aircraft, workers in the World  
14 Trade Center and in the Pentagon, rescue workers, and bystanders; and,

15 WHEREAS, These attacks destroyed both towers of the World Trade Center, as well  
16 as adjacent buildings, and seriously damaged the Pentagon; and

17 WHEREAS, these attacks were by far the deadliest terrorist attacks ever launched  
18 against the United States, and by targeting symbols of American Strength and success,  
19 clearly were intended to intimidate our Nation and weaken its resolve; and

20 WHEREAS, The House Joint Resolution expressing the sense of Congress was  
21 introduced by House Majority Leader Dick Armey and Minority Leader Richard Gephardt on  
22 September 11<sup>th</sup>, 2001 in the 107<sup>th</sup> Congress first session; and

23 WHEREAS, HR: 2888 the "2001 Emergency Supplemental Appropriations Act for  
24 Recovery from and Response to Terrorist Attacks of the United States" was introduced on  
25 Wednesday September 12<sup>th</sup>, 2001; and

1           WHEREAS, House Resolution 2888 will go to providing support to counter, investigate,  
2 or prosecute domestic or International terrorism; and

3           WHEREAS, House Resolution 2888 will go to providing Federal, State and Local  
4 preparedness for mitigating and responding to the attacks; and

5           WHEREAS, House Resolution 2888 will go to providing increased transportation  
6 security; and

7           WHEREAS, House Resolution 2888 will go to repairing public facilities and  
8 transportation systems damaged by these attacks; and

9           WHEREAS, House Resolution 2888 will go to supporting national security; now  
10 therefore, be it

11           RESOLVED, The City of San Francisco condemns in the strongest possible terms the  
12 terrorists who planned and carried out the September 11, 2001 attacks against the United  
13 States, as well as their sponsors

14           FURTHER RESOLVED, That the City and County of San Francisco extends it's  
15 deepest condolences to the victims of these heinous and cowardly attacks, as well to their  
16 families, friends and loved ones;

17           FURTHER RESOLVED, That the City and County of San Francisco commends the  
18 heroic actions of these rescue workers, volunteers, and state and local officials who  
19 responded to these tragic events with courage determination and skill

20           FURTHER RESOLVED, That the City and County of San Francisco thanks those  
21 foreign leaders and individuals who have expressed solidarity with the United States in the  
22 aftermath of the attacks, and asks them to continue to stand with the United States in the war  
23 against International terrorism

1           FURTHER RESOLVED, That the City and County of San Francisco supports the  
2 determination of the President, in close consultation with the Congress, to punish the  
3 perpetrators of these attacks as well as their sponsors; and

4           FURTHER RESOLVED, That the City and County of San Francisco does hereby  
5 support House of Representatives Joint Resolution expressing the Sense of Congress and  
6 HR: 2888 the "2001 Emergency Supplemental Appropriations Act for Recovery from and  
7 Response to Terrorist Attacks of the United States"


