The Commission and Department on the Status of Women fosters the equitable treatment and the advancement of all women and girls throughout San Francisco through policies, legislation, and programs.

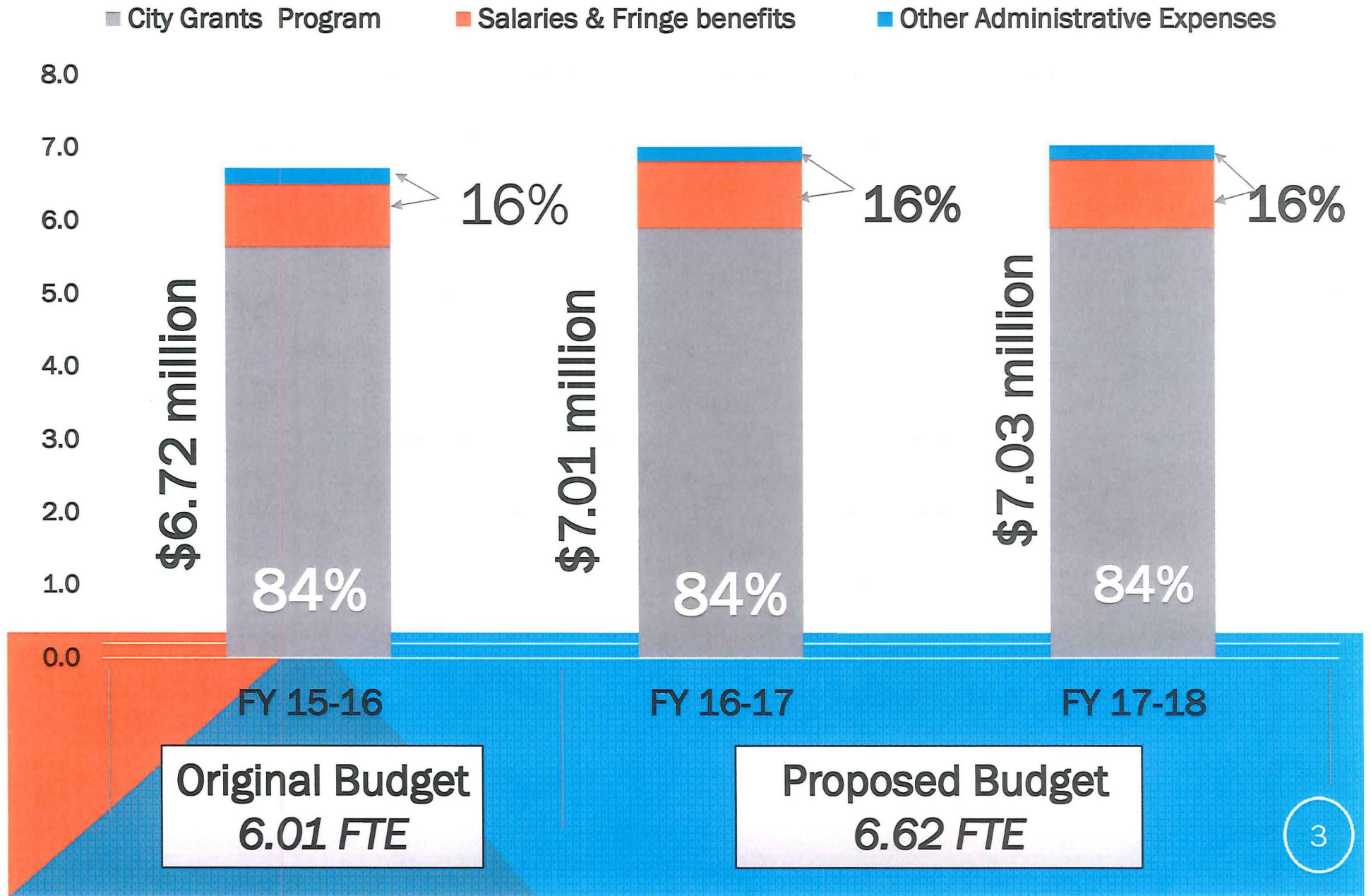

# 3-YEAR BUDGET TREND





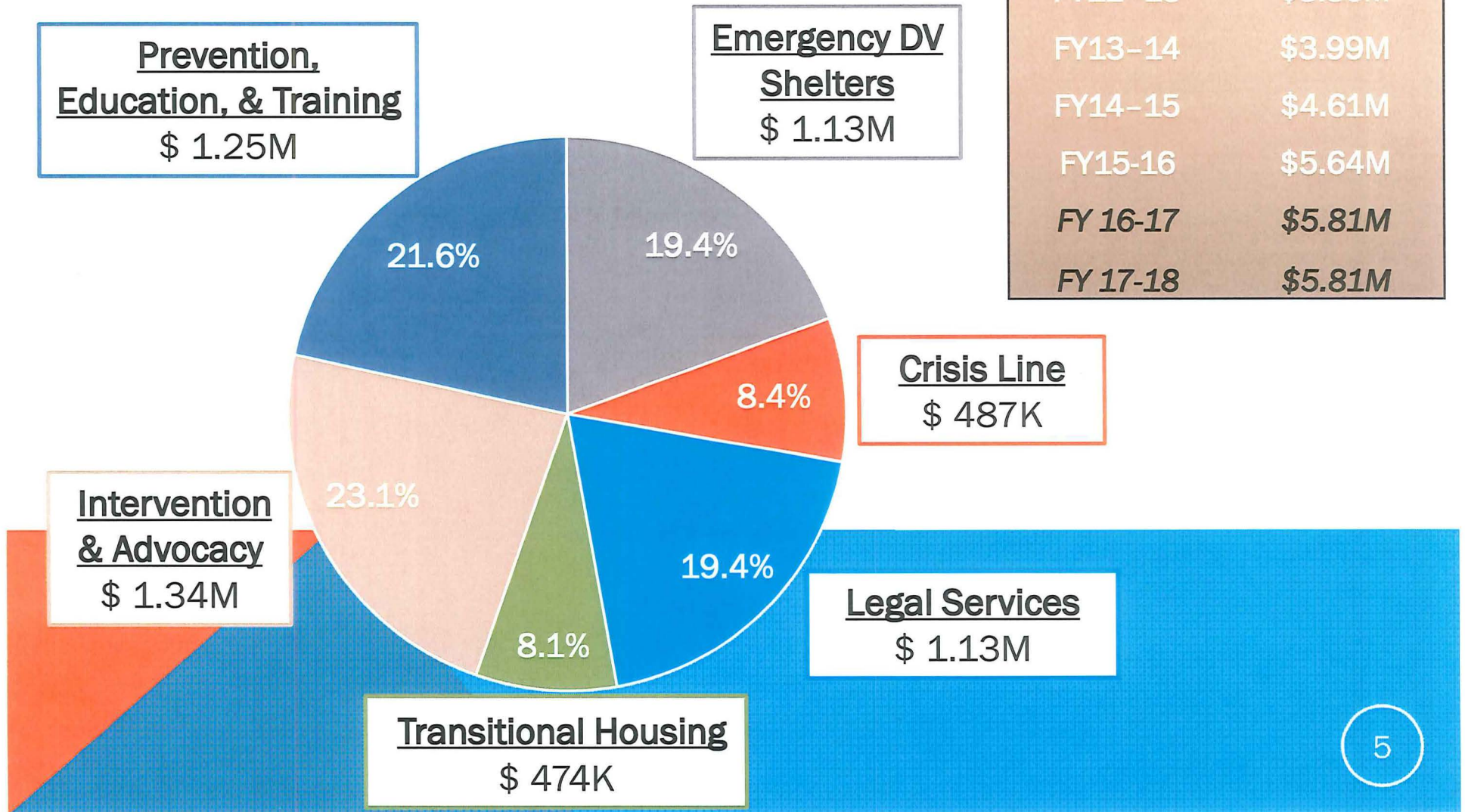
# MAJOR BUDGET CHANGES

- **2.5% Increase** for General Fund grant budget that addresses domestic violence, sexual assault, and human trafficking.
- **2.5% Cost of Doing Business Increase** to all grantees.
- **0.5 FTE Increase** from U.S. Department of Justice Violence Against Women Act Grant, FY16-17 and FY17-18.
- 24-hour Response for Commercially Sexually Exploited Children Pilot (**\$230,000 current year; \$327,000 budget year**) moved to HSA to manage grant, funded by DCYF workorder.
- **\$5,000 reduction** in Materials & Supplies in FY 16-17 and **\$5,000 reduction** to Non-Personnel Expenses in FY 17-18.

# VAW GRANTS PROGRAM

Outcomes for FY 2014-2015

- **\$4.6 million** allocation
- **33** Community Programs
- **24,418** unduplicated individuals served
- **31,297** hours of supportive services
- **10,450** bed nights at emergency shelters, transitional housing programs
- **23,229** crisis calls fielded



# DEPARTMENT INITIATIVES, FY16-17

- **Mayor's Task Force on Human Trafficking:**
  - Fully staff 24-hour Commercially Sexually Exploited Children Response (piloted in FY15-16), review foster care system
  - Partner with Dept of Environment to expand nail salon outreach to include labor rights/labor trafficking
- **Needs assessment for next grants cycle to explore nexus between DV + homelessness**
- **Resume Gender Equality Principles Challenge**
- **CCSF Gender Analysis of Trades, Law Enforcement, Technology Positions**
