Ordinance making environmental findings and amending San Francisco Park Code, Article 12, Section 12.07, to increase the fees for holding weddings in San Francisco parks.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.).

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.07, to read as follows:

## SEC. 12.07. WEDDING FEES.

- (a) A fee of \$500.00 for the first two hours shall be charged to conduct wedding ceremonies and receptions at the Chinese Pavilion, Palace of Fine Arts Rotunda, Shakespeare Garden and Queen Wilhelmina Garden. A fee of \$100.00 for each additional hour after two hours shall be charged.
- (b) A fee of \$250.00 for the first two hours shall be charged to conduct wedding ceremonies and receptions at all other parks. A fee of \$50.00 for each additional hour after two hours shall be charged.
