Third Amendment

THIS AMENDMENT (this "Amendment") is made as of February 28, 2022, in San Francisco, California, by and between **Active Network**, **LLC** ("Contractor"), and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Director of the Office of Contract Administration.

RECITALS

WHEREAS, City and Contractor have entered into the Agreement (as defined below); and WHEREAS, City and Contractor desire to modify the Agreement on the terms and conditions set forth herein to extend performance period;

NOW, THEREFORE, Contractor and the City agree as follows:

- 1. **Definitions.** The following definitions shall apply to this Amendment:
- **1a. Agreement.** The term "Agreement" shall mean the Agreement dated January 1, 2016 between Contractor and City, as amended by the:

First Amendment, dated December 11, 2017. Second Amendment dated December 27, 2019.

- **1b. Other Terms.** Terms used and not defined in this Amendment shall have the meanings assigned to such terms in the Agreement.
- **2. Modifications to the Agreement.** The Agreement is hereby modified as follows:
 - 2a. Section 4. Section 4 Term of the Agreement of the Agreement currently reads as follows:
 - **4. Term of the Agreement.** Subject to Section 1, the term of this Agreement shall be from **January 1, 2016 to January 1, 2022** (the "Initial Term"). One year prior to the conclusion of the Initial Term the parties may mutually agree in writing to extend the term of this Agreement for additional two year terms under the same terms and conditions set forth herein (each a "Renewal Term"). This Agreement shall become effective on the Effective Date.

Such section is hereby amended in its entirety to read as follows:

4. Term of the Agreement. Subject to Section 1, the term of this Agreement shall be from **January 1, 2016 to December 31, 2025** (the "Initial Term"). One (1) year prior to the conclusion of the Initial Term the parties may mutually agree in writing to extend the term of this Agreement for additional two (2) year terms under the same terms and conditions set forth herein (each a "Renewal Term") as long as all City contract approval requirements are met. This Agreement shall become effective on the Effective Date.

- **2b.** Appendix C. Appendix C is hereby replaced in its entirety by Appendix C-1, attached to this Amendment and fully incorporated within the Agreement. To the extent the Agreement refers to Appendix C in any place, the true meaning shall be Appendix C-1, which is a correct and updated version.
- **3. Effective Date.** Each of the modifications set forth in Section 2 shall be effective on and after February 28, 2022.
- **4. Legal Effect.** Except as expressly modified by this Amendment, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect.
