2 **Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to accept and**
3 **expend a grant in the amount of \$200,000 from the Department of Justice (DOJ), Office**
4 **of Justice Programs (OJP), FY2007 Weed and Seed Program for the purpose of**
5 **supporting activities to prevent, control and reduce violent crime, drug abuse, and**
6 **gang activity in the designated Weed and Seed area in the Visitacion Valley**
7 **neighborhood.**

8 WHEREAS, MOCJ is the lead fiscal agency in administering the Weed and Seed
9 Program; and

10 WHEREAS, San Francisco applied and was awarded on August 3, 2007, two hundred
11 thousand dollars (\$200,000); and

12 WHEREAS, The Mayor's Office of Criminal Justice in partnership with the San
13 Francisco Police Department, the Visitacion Valley Community Center and the U.S. Attorney's
14 Office for the Northern District of California will be responsible for coordination and day-to-day
15 operations of the planning and implementation phases of this grant; and

16 WHEREAS, MOCJ will be responsible for the fiscal, programmatic and administrative
17 reporting to OJP; now, therefore, be it


18 RESOLVED, That the City and County of San Francisco hereby authorizes MOCJ to
19 accept and expend \$200,000 from the Office of Justice Programs, to administer the Weed and
20 Seed Program; and

21 WHEREAS, the grant terms prohibit including indirect costs in the grant budget; now,
22 therefore be it

23 FURTHER RESOLVED, That the City and County of San Francisco hereby waives
24 inclusion of indirect costs in the grant budget.
