9 WHEREAS, the people of the State of California have enacted the California Oil
10 Recycling Enhancement Act that provides funds to cities and counties for establishing and
11 maintaining local used oil collection programs that encourage recycling or appropriate
12 disposal of used oil; and,

13 WHEREAS, the California Integrated Waste Management Board has been delegated
14 the responsibility for the administration of the program with the State, setting up necessary
15 procedures governing application by cities and counties under the program; and,

16 WHEREAS, the City and County of San Francisco will enter into agreement with the
17 State of California for implementation of used oil collection programs; and,

18 WHEREAS, the grant is a non-competitive grant that is available to the City and
19 County of San Francisco from the California Integrated Waste Management Board; and,

20 WHEREAS, the grant terms prohibit including indirect cost in the grant budget; now,
21 therefore, be it


22 RESOLVED, that the Director of the Department of the Environment, or the designee,
23 is hereby authorized and empowered to execute in the name of the City and County of San
24 Francisco all necessary applications, contracts, payments and carry out the purpose specified
25 in the grant application; and be it


1 FURTHER RESOLVED, that the Board of Supervisors hereby waives inclusion of


