3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:

8 **RESIDENTIAL PERMIT PARKING AREA "Z" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
9 **MONDAY THROUGH FRIDAY) - ESTABLISH**

10 26th Street, both sides, between Church and Dolores Streets (3800 Block).

11 **NO PARKING ANYTIME - RESCIND**
12 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

13 Kimball Street east side, south of Sacramento Street.

14 **UNMETERED MOTORCYCLE PARKING - RESCIND**

15 32nd Avenue, east side, from 215 feet north of Anza Street to 25 feet northerly (leaving
16 4 motorcycle parking spaces).

17 **NO PARKING ANYTIME - ESTABLISH**

18 Le Conte Circle, both sides, at Le Conte Avenue; and,

19 Stanyan Street, west side, within the intersection of Hayes Street.

20 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**


21 4th Street, east side, from 42 to 82 feet south of Market Street; and,

22 Paulding Street, south side, from the Arago Street intersection to 115 feet westerly.

24 **RESIDENTIAL PERMIT PARKING AREA "N" (2-HOUR TIME LIMIT, 9 AM - 6 PM,**
25 **MONDAY THROUGH FRIDAY) - ESTABLISH**

1 Fulton Street, north side, between Funston and 10th Avenue (3400, 3500, 3600
2 blocks).

3 Categorically exempt from Environmental Review
4 Class 1(c)(9) changes in the traffic and parking
5 regulations where such changes do not establish a
6 higher speed limit or result in more than a negligible
7 increase in the use of the street.




