Your focus on creating standards for us to be “the cleanest and safest” hotels in the nation is also farcical. Your governance has already made the city a place where tourist are cautious to travel. Oracle in our own backyard left us, multiple conventioners mention they well never return – all before the pandemic and all because of your failed policies that you continue to enact and perpetuate.


Your “double whammy” of legislation targeted at our industry only will make our industry’s recovery that much longer if even at all. The golden goose has no eggs left to take, please work on legislation that helps build us back up and not laws that continue to break us down further.

I am writing on behalf of the San Francisco Travel Association, a not for profit organization that markets San Francisco to visitors as a destination, globally. We represent over 1,300 business members which help to make tourism San Francisco's number one industry, employing over 86,000 hard working professionals. San Francisco welcomed over 25 million visitors last year who spent \$10 Billion, generating over \$770 Million in General Fund revenues in 2019 alone.

However, these numbers are almost non-existent today. The Coronavirus pandemic has completely decimated the travel and tourism industry in San Francisco. More than half of those employed have been furloughed or laid off. Our industry was hit hard at the onset of this pandemic and will be one of the slowest industries to recover due to our local reopening phases, businesses ability to recover, as well as consumer confidence in traveling.

As the City works to slowly and carefully reopen, we are focused on recovery efforts and working with our partners to be able to once again welcome business and leisure visitors back to San Francisco to support our small businesses, hotels, museums, attractions and restaurants.

What our businesses need at this time to support the return of visitors is stimulus measures and not additional tax burdens. Our visitor supporting businesses are struggling to survive-and many won't be able to recover at all. Therefore, we are concerned about the various gross receipts tax proposals being considered for the November 2020 ballot. We believe that additional taxes at a time when economic recovery is vital will hamper our efforts to rebuild, reopen and reemploy.

Additionally, the travel and tourism industry will take years to recover from this pandemic, the biggest crisis yet to hit our industry. If San Francisco wants to increase their general fund revenues, incentivize visitors to come to San Francisco and make it easier for visitor serving businesses to operate. The spending from visitors will generate revenues to support the City's budget in this time of need.

Many of the tourism related businesses are high volume with low margins and therefore a gross receipts tax will cause an undue burden. If any business tax measure is put forward, we request that visitor serving businesses that are vital to our City's tourism economy, a very fragile and cost sensitive industry,

be provided additional relief so that our City can show our resilience and safely welcome back visitors to our beautiful city.
