16 WHEREAS, The Budget Analyst Joint Venture wishes to replace the Harvey M. Rose
17 Accountancy Corporation with a new entity, Harvey M. Rose. Associates, LLC; and,

18 WHEREAS, The Harvey M. Rose Accountancy Corporation warrants that the formation
19 of the Harvey M. Rose Associates LLC is not being undertaken in order to establish a pass
20 through entity for the purpose of reducing its business payroll tax liability; now , therefore, be it

21 MOVED, That the Board of Supervisors hereby amends its Agreement with the Budget
22 Analyst Joint Venture to change the composition of the Joint Venture, replacing the Harvey M.
23 Rose Accountancy Corporation with Harvey M. Rose Associates, LLC, and, be it

24 FURTHER MOVED, That the Clerk of the Board of Supervisors is authorized and
25 directed to take all administrative steps necessary to carry out the intent of this motion.


