

3 **Resolution supporting California Senate Bill 1172, which bans sexual orientation**
4 **change efforts for minors in the State of California.**

5
6 WHEREAS, Senate Bill 1172, which would ban children under the age of eighteen from
7 undergoing sexual orientation change efforts, is currently pending in the California State
8 Assembly; and

9 WHEREAS, An individual's sexual orientation is not a disease, disorder, or illness; and

10 WHEREAS, There is no evidence that any type of psychotherapy can change a
11 person's sexual orientation; and

12 WHEREAS, Such practices of sexual orientation change efforts pose detrimental
13 mental health risks to gay, lesbian and bisexual people including depression, guilt,
14 hopelessness, shame, suicidal ideation and substance abuse, among other forms of
15 psychological and emotional distress; and

16 WHEREAS, Minors who experience rejection by their family based on their sexual
17 orientation face a variety of critical health issues, including depression, illegal drug use, and
18 suicide attempts; and

19 WHEREAS, The American Psychiatric Association, the American Psychological
20 Association, the American Counseling Association, the American Association of Marriage and
21 Family Therapists, the National Association of Social Workers, and the American Academy of
22 Pediatrics oppose efforts to change the sexual orientation of any individual; and

23 WHEREAS, SB 1172 prohibits therapists from engaging in harmful practices that seek
24 to change a minor's sexual orientation or the expression of the young person's sexual
25 orientation; and

1 WHEREAS, the City and County of San Francisco is home to a large and diverse
2 LGBT community, including many LGBT people who have come to San Francisco as a refuge
3 from discrimination and oppres, San Francisco being unwaivering in its commitment to
4 provide a safe and respectful environment for individuals from all walks of life; now, therefore,
5 be it

6 RESOLVED, that the City and County of San Francisco hereby supports California SB
7 1172.

SENATE BILL

No. 1172

Introduced by Senator Lieu
(Coauthor: Assembly Member Ma)

February 22, 2012

An act to add Article 15 (commencing with Section 865) to Chapter 1 of Division 2 of the Business and Professions Code, relating to healing arts.

LEGISLATIVE COUNSEL'S DIGEST

SB 1172, as amended, Lieu. Sexual orientation change efforts.

Existing law provides for licensing and regulation of various professions in the healing arts, including physicians and surgeons, psychologists, marriage and family therapists, educational psychologists, clinical social workers, and licensed professional clinical counselors.

This bill would prohibit ~~psychotherapists~~ *a mental health provider*, as defined, from ~~performing~~ *engaging in* sexual orientation change efforts, as defined, ~~in the absence of informed consent of the~~ *with a patient under 18 years of age*. ~~The bill would require a specified statement to be included on the informed consent form. Informed consent would not be effective for patients under 18 years of age. The bill would provide for a cause of action against psychotherapists by patients, former patients, or certain other persons in specified cases.~~

The bill would also declare the intent of the Legislature in this regard.

The people of the State of California do enact as follows:

1 SECTION 1. The Legislature finds and declares all of the
2 following:

3 (a) ~~An individual's sexual orientation, whether homosexual,~~
4 ~~Being lesbian, gay, or bisexual, or heterosexual,~~ is not a disease,
5 disorder, illness, deficiency, or shortcoming. The major
6 professional associations of mental health practitioners and
7 researchers in the United States have recognized this fact for nearly
8 40 years.

9 (b) ~~Sexual~~ *The American Psychological Association convened*
10 *a Task Force on Appropriate Therapeutic Responses to Sexual*
11 *Orientation. The task force conducted a systematic review of*
12 *peer-reviewed journal literature on sexual orientation change*
13 *efforts, and issued a report in 2009. The task force concluded that*
14 *sexual orientation change efforts can pose critical health risks to*
15 *lesbian, gay, and bisexual people, including confusion, depression,*
16 *guilt, helplessness, hopelessness, shame, social withdrawal,*
17 *suicidality, substance abuse, stress, disappointment, self-blame,*
18 *decreased self-esteem and authenticity to others, increased*
19 *self-hatred, hostility and blame toward parents, feelings of anger*
20 *and betrayal, loss of friends and potential romantic partners,*
21 *problems in sexual and emotional intimacy, sexual dysfunction,*
22 *high-risk sexual behaviors, a feeling of being dehumanized and*
23 *untrue to self, a loss of faith, and a sense of having wasted time*
24 *and resources. This is documented by the American Psychological*
25 *Association's Task Force on Appropriate Therapeutic Responses*
26 *to Sexual Orientation in its 2009 Report of the Task Force on*
27 *Appropriate Therapeutic Responses to Sexual Orientation.*

28 (c) (1) ~~The American Psychological Association, in its 1997~~
29 ~~Resolution on Appropriate Therapeutic Responses to Sexual~~
30 ~~Orientation, states: "We oppose portrayals of lesbian, gay and~~
31 ~~bisexual youth and adults as mentally ill due to their sexual~~
32 ~~orientation and support the dissemination of accurate information~~
33 ~~about sexual orientation and mental health and appropriate~~

1 interventions in order to counteract bias that is based in ignorance
2 of unfounded beliefs about sexual orientation.”

3 ~~(2) The American Psychological Association also convened a
4 Task Force on Appropriate Therapeutic Responses to Sexual
5 Orientation. The task force conducted a systematic review of
6 peer-reviewed journal literature on sexual orientation change
7 efforts. It concluded: “Efforts to change sexual orientation are
8 unlikely to be successful and involve some risk of harm, contrary
9 to the claims of sexual orientation change efforts practitioners and
10 advocates.”~~

11 *(c) The American Psychological Association issued a resolution
12 on Appropriate Affirmative Responses to Sexual Orientation
13 Distress and Change Efforts in 2009, which states: “[T]he
14 [American Psychological Association] advises parents, guardians,
15 young people, and their families to avoid sexual orientation change
16 efforts that portray homosexuality as a mental illness or
17 developmental disorder and to seek psychotherapy, social support,
18 and educational services that provide accurate information on
19 sexual orientation and sexuality, increase family and school
20 support, and reduce rejection of sexual minority youth.”*

21 *(d) The American Psychiatric Association published a position
22 statement in March of 2000 in which it stated: “The*

23 *“Psychotherapeutic modalities to convert or ‘repair’
24 homosexuality are based on developmental theories whose
25 scientific validity is questionable. Furthermore, anecdotal reports
26 of ‘cures’ are counterbalanced by anecdotal claims of
27 psychological harm. In the last four decades, ‘reparative’
28 therapists have not produced any rigorous scientific research to
29 substantiate their claims of cure. Until there is such research
30 available, [the American Psychiatric Association] recommends
31 that ethical practitioners refrain from attempts to change
32 individuals’ sexual orientation, keeping in mind the medical dictum
33 to first, do no harm.*

34 *“The potential risks of reparative therapy are great, including
35 depression, anxiety and self-destructive behavior, since therapist
36 alignment with societal prejudices against homosexuality may
37 reinforce self-hatred already experienced by the patient. Many
38 patients who have undergone reparative therapy relate that they
39 were inaccurately told that homosexuals are lonely, unhappy
40 individuals who never achieve acceptance or satisfaction. The*

1 *possibility that the person might achieve happiness and satisfying*
2 *interpersonal relationships as a gay man or lesbian is not*
3 *presented, nor are alternative approaches to dealing with the*
4 *effects of societal stigmatization discussed.*

5 *“Therefore, the American Psychiatric Association opposes any*
6 *psychiatric treatment such as reparative or conversion therapy*
7 *which is based upon the assumption that homosexuality per se is*
8 *a mental disorder or based upon the a priori assumption that a*
9 *patient should change his/her sexual homosexual orientation.”*

10 (e) The American School Counselor Association’s position
11 statement on professional school counselors and lesbian, gay,
12 bisexual, transgendered, and questioning (LGBTQ) youth states:
13 “It is not the role of the professional school counselor to attempt
14 to change a student’s sexual orientation/gender identity but instead
15 to provide support to LGBTQ students to promote student
16 achievement and personal well-being. Recognizing that sexual
17 orientation is not an illness and does not require treatment,
18 professional school counselors may provide individual student
19 planning or responsive services to LGBTQ students to promote
20 self-acceptance, deal with social acceptance, understand issues
21 related to coming out, including issues that families may face when
22 a student goes through this process and identify appropriate
23 community resources.”

24 (f) The American Academy of Pediatrics in 1993 published an
25 article in its journal, *Pediatrics*, stating: “Therapy directed at
26 specifically changing sexual orientation is contraindicated, since
27 it can provoke guilt and anxiety while having little or no potential
28 for achieving changes in orientation.”

29 (g) The American Medical Association’s *Association Council*
30 *on Scientific Affairs* prepared a report in 1994 in which it stated:
31 “Aversion therapy (a behavioral or medical intervention which
32 pairs unwanted behavior, in this case, homosexual behavior, with
33 unpleasant sensations or aversive consequences) is no longer
34 recommended for gay men and lesbians. Through psychotherapy,
35 gay men and lesbians can become comfortable with their sexual
36 orientation and understand the societal response to it.”

37 (h) The National Association of Social Workers prepared a 1997
38 policy statement in which it stated: “Social stigmatization of
39 lesbian, gay and bisexual people is widespread and is a primary
40 motivating factor in leading some people to seek sexual orientation

1 changes. Sexual orientation conversion therapies assume that
2 homosexual orientation is both pathological and freely chosen. No
3 data demonstrates that reparative or conversion therapies are
4 effective, and, in fact, they may be harmful.”

5 (i) *The American Counseling Association Governing Council*
6 *issued a position statement in April of 1999, and in it the council*
7 *states: “We oppose ‘the promotion of “reparative therapy” as a*
8 *“cure” for individuals who are homosexual.”*

9 (j) *The Pan American Health Organization, a regional office*
10 *of the World Health Organization, issued a statement in May of*
11 *2012 and in it the organization states: “These supposed conversion*
12 *therapies constitute a violation of the ethical principles of health*
13 *care and violate human rights that are protected by international*
14 *and regional agreements.” The organization also noted that*
15 *reparative therapies “lack medical justification and represent a*
16 *serious threat to the health and well-being of affected people.”*

18 (k) *Minors who experience family rejection based on their sexual*
19 *orientation face especially serious health risks. In one study,*
20 *lesbian, gay, and bisexual young adults who reported higher levels*
21 *of family rejection during adolescence were 8.4 times more likely*
22 *to report having attempted suicide, 5.9 times more likely to report*
23 *high levels of depression, 3.4 times more likely to use illegal drugs,*
24 *and 3.4 times more likely to report having engaged in unprotected*
25 *sexual intercourse compared with peers from families that reported*
26 *no or low levels of family rejection. This is documented by Caitlin*
27 *Ryan et al. in their article entitled Family Rejection as a Predictor*
28 *of Negative Health Outcomes in White and Latino Lesbian, Gay,*
29 *and Bisexual Young Adults (2009) 123 Pediatrics 346.*

31 (l) *California has a compelling interest in protecting the lives*
32 *and health of physical and psychological well-being of minors,*
33 *including lesbian, gay, and bisexual people, and transgender youth,*
34 *and in protecting its minors against exposure to serious harms*
35 *caused by sexual orientation change efforts.*

36 (m) *Nothing in this act is intended to prevent a minor who is*
37 *12 years of age or older from consenting to any mental health*
38 *treatment or counseling services, consistent with Section 124260*
39 *of the Health and Safety Code, other than sexual orientation*
40 *change efforts as defined in this act.*

9 ~~(a) "Informed consent" means consent that is voluntarily~~

13 ~~orientation change efforts and include a statement as set forth in~~

22 associate clinical social worker, a licensed professional clinical

11 ~~attractions, or conduct toward another person of the same sex.~~

12 ~~(f) "Therapeutic relationship" means the relationship that exists~~

22 865.1. (a) Under no circumstances shall a mental health
23 provider engage in sexual orientation change efforts with a patient
24 under 18 years of age undergo sexual orientation change efforts,
25 regardless of the willingness of a patient, patient’s parent, guardian,
26 conservator, or other person to authorize such efforts.

27 (b) The right to refuse sexual orientation change efforts is not
28 waived by giving informed consent and that consent may be
29 withdrawn at any time prior to, during, or between sessions of
30 sexual orientation change efforts.

31 (c) Any act of duress or coercion by any person or facility shall
32 invalidate the patient’s consent to sexual orientation change efforts.

33 865.3. (a) (1) A cause of action may be brought against a
34 psychotherapist by a patient, former patient, or deceased former
